## Agreement

Whereas, in consideration of being permitted to attend a course for instruction in firearms, for the instruction in firearms, for the use of the premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Undersigned agrees to the following;

Undersigned further acknowledges that, any and all safety violations, as determined by the instructor, **Joe Brown Scorpion Defense Training Group LLC** are grounds for immediate and or final dismissal from the course and forfeit of all monies to the Instructor. Undersigned also acknowledges that the instructor Joe Brown has complete and final say when it comes to safety, instruction, the course, commands given on the range, and in any other capacity involving this agreement from start to finish; no exceptions or appeals. Instructor **Joe Brown, Scorpion Defense Training Group LLC** has the final say.

Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy, and each and every, remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statue or otherwise. The election of anyone or more remedy, hereunder by the Instructor **Joe Brown**, **Scorpion Defense Training Group LLC** shall not constitute any waiver of Instructor's **Joe Brown Scorpion Defense Training Group LLC** right to pursue other available Remedies.
